Notice on Registration for Hajj Pilgrims – Hajj 2027

We are pleased to inform that registration has commenced for Sri Lankan Muslim pilgrims wishing to undertake the sacred pilgrimage of **Hajj in 2027**. Kindly note that registration will be conducted **exclusively through the online system**.

02. Accordingly, all prospective pilgrims intending to perform Hajj in **2027** must fulfil the following eligibility criteria:

- Must be a **Sri Lankan Muslim**.
- Must be **15 years of age or above** as of **09.03.2027** (the final date for visa issuance).
- Must **not have performed Hajj in the year 2026**.

03. Applicants are required to complete their registration through the online link provided by the Department of Muslim Religious and Cultural Affairs (DMRCA) or by scanning the QR Code provided by furnishing a **valid National Identity Card (NIC) number** and **Mobile number**. Family members may also be registered under the same application. Children who have attained **15 years of age** but are unable to provide an NIC number may complete registration by submitting their **date of birth**.

04. Please note that all **Hajj-related notifications, instructions, and updates** issued by the Department will be communicated via **SMS** to the mobile number used at the time of registration. Therefore, applicants are kindly requested to provide **their personal mobile number** when registering.

05. Therefore, Pilgrims are strongly advised to **avoid registering through Hajj Travel Operators, Sub Agents or intermediaries** and to complete the registration process independently through the official system.

However, such applicants **will not be required to pay the registration fee again**, and their **previous year's registration number will be assigned as the re-registration number**.
